- a.) To declare SAMMY'S AIRCONDITIONING AND REFRIGERATION SERVICES & REPAIR SHOP _as the SINGLE CALCULATED and RESPONSIVE BID for items no. 2, 3, 4, 5, 6, 7 & 8 in the amount of P 451,885.00, for the Procurement of AIRCONDITIONING UNIT, BIOLOGICAL REFRIGERATOR AND UPRIGHT FREEZER under Project Reference No.- PHO - 2021-016; while item no. 1 having no quotation from the supplier is for rebidding.
- b.) To recommend award to <u>SAMMY'S AIRCONDITIONING AND REFRIGERATION SERVICES & REPAIR SHOP.</u> in the contract amount of FOUR HUNDRED FIFTY ONE THOUSAND EIGHT HUNDRED EIGHTY FIVE PESOS ONLY (P 451,885.00),
