WHEREAS, the **PROVINCIAL GENERAL SERVICES OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2021-0003** re: **PROCUREMENT OF RENOVATION OF OLD PADMO OFFICE AT GOVERNOR'S MANSION COMPOUND,CPG. AVE. TAGBILARAN CITY** with an ABC of **₱ 340,981.95**;




