WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 20-1058 series of 2020 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL ENGINEER'S OFFICE in undertaking Procurement Request under PR No. 2020-0545 re: Procurement of Materials (Anapog) for the Maintenance of Various Provincial Roads for Project Management Division (PMD I), by the Provincial Engineer's Office, New Capitol Site, Tagbilaran City, with an ABC of ₱1,187,500.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BNYU DEVELOPMENT CORPORATION offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, BNYU DEVELOPMENT CORPORATION has been found to be ELIGIBLE and its bid, RESPONSIVE;
