WHEREAS, the BOHOL INVESTMENT PROMOTION CENTER of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0523; re; Procurement of 3 Seater Modular Cubicle, Cabinet with Plant Box, Wall Display Cabinet, TV Rack & Wall Cladding for use at Bohol Investment Promotion Center, Capitol Complex, Tagbilaran City. with an ABC of P 423,700.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that SKETCHES & PLOTS FURNITURE & FIXTURES ENTERPRISE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;




