WHEREAS, the <u>PROVINCIAL ECONOMIC ENTERPRISE MANAGEMENT OFFICE</u>, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2020-0405</u>, re; <u>Procurement of Office Tables, Office Chairs, Curtain w/ Ring & Curtain Rod, Wooden Coffee Table, Interior Decorations & Paintings & Filing Cabinet for use at Provincial Economic Enterprise Management Office, New Capitol Site, Tagbilaran City. with an ABC of <u>P 99,870.00</u>;</u>

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>SKETCHES & PLOTS</u> <u>& FURNITURES & FIXTURES ENTERPRISES</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations:
