WHEREAS, the OFFICE OF THE PROVINCIAL VETERINARIAN of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021-0089 re: Procurement of Disinfectant, for ASF (African Swine Fever) and COVID-19 Corona Virus (Disease) Prevention, Office of the Provincial Veterinarian, Bohol Provincial Capitol Compound, Cocon District, Tagbilaran City, with an ABC of P 1,000,050.00;
