WHEREAS, the PROVINCIAL GENERAL SERVICES OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0062; Te; Procurement of Diesel and Gasoline for the Mobilization of PGSO and Fuel for Generators and other Equipment. Provincial General Services Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City with an ABC of P 498,060.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BOHOL PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
