WHEREAS, the PROVINCIAL LEGAL OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0079, re; Procurement of Diesel & Unleaded for the use at the Provincial Legal Office, New Capitol Compound, Tagbilaran City, Bohol. with an ABC of P 199,999.50;
