



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **PROVINCIAL LEGAL OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. **2021-0079**; re; **Procurement of Diesel & Unleaded for the use at the Provincial Legal Office, New Capitol Compound, Tagbilaran City, Bohol**, with an ABC of **P 199,999.50**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **BOHOL PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **BOHOL PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **BOHOL PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:


- a.) To declare **BOHOL PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE** as the bidder with the **LOWEST CALCULATED AND RESPONSIVE BID** for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. **2021-0056**;
- b.) To recommend award to **BOHOL PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE** for the delivery of goods/services under Negotiated Canvass No. **2021-0056** in the amount of **P 199,997.18**;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.






