WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0091 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE PROVINCIAL SOCIAL WELFARE & DEVELOPMENT in undertaking Procurement Request under PR No. 2020-0160 re: Procurement of Multi-purpose Vehicle for the use at the Office of the Provincial Social Welfare & Development, Tagbilaran City. with an ABC of P 1,927,000.00

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that TOYOTA TAGBILARAN CITY offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;
