

BAC Resolution Recommending the Use of Negotiated Procurement through Emergency Cases, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **PROVINCIAL ENGINEER'S OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Request No. **2021-0143** re: **Procurement of Diesel for use of Heavy Equipment, Service Vehicles, for PMD 1,2,3 & other Division, Assigned by Provincial Engineer's Office (PEO), Bohol Provincial Capitol Compound, Cogon District, Tagbilaran City, with an ABC of P 2,499,983.37;**

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **PETROBEST (PETRON) SERVICENTER** offered the lowest price quotation as reflected in the Abstract of Bid Quotations,
