



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

AUXTERO, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0167; re; Procurement of Repair & Replacement of Wornout & Defective Parts of Service Vehicle with Plate No. SKY # 346, Assigned at the Office of the Board Member Restituto B. Auxtero, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, Bohol, with an ABC of P 65,945.00;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:






