

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-095 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE GOVERNOR in undertaking Procurement Request under PR No. 2021-0030 re: Procurement of Binding Machine, Powershred 990 Cross-cut Shredder & Electronic Stapler, by the Office of the Governor, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, with an ABC of P 157,711.50;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that SOFIA PLUS TRADING and COPYLANDIA OFFICE SYSTEMS, CORP. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
