**CONTRACT AGREEMENT**

THIS AGREEMENT, made this 6<sup>TH</sup> day of April, 2021 between Provincial General Services Office of Provincial Government of Bohol (hereinafter called the "Entity") and LAWRENCE BUILDERS & SUPPLY of Pondol, Loon, Bohol (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **RENOVATION OF OLD BTO OFFICE AT THE GOVERNOR'S MANSION COMPOUND, CPG AVENUE, TAGBILARAN CITY** (hereinafter called "the Works") and the Entity has accepted the Bid for **₱ 660,711.00 in Six Hundred Sixty Thousand Seven Hundred Eleven Pesos Only** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

WHEREAS, Project shall be completed in **30 Calendar Days** in accordance with the provisions of the Bid Documents;
