

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the GO - BOHOL INFORMATION AND COMMUNICATION TECHNOLOGY UNIT of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0109; re; Procurement of ISP Load Manager and Aggregator, by the GO - Bohol Information and Communication Technology Unit, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, with an ABC of P 400,000.00.
