WHEREAS, the GOVERNOR'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2021-C-056 re: PROCUREMENT OF MEALS AND SNACKS DURING THE SERIES OF MEETINGS, STRATEGIC AND OPERATIONAL PLANNING WORKSHOP, ASSESSMENT ACTIVITIES, CAPACITY DEVELOPMENT, TECHNICAL TRAINING AND SEMINARS OF THE PROVINCIAL PEACE AND ORDER COUNCIL (PPOC) AND PADAC MEMBER OFFICES/ AGENCIES with an ABC of P 205, 000.00;



- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.


