

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the GARCIA MEMORIAL PROVINCIAL HOSPITAL, TALIBON, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2020 - 358 re: PROCUREMENT OF HOUSEKEEPING AND OFFICE SUPPLIES with an ABC of P 189,633.00;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:



- b.) To recommend award to BOHOL QUALITY CORPORATION in the amount of **ONE HUNDRED FORTY SIX THOUSAND FOUR HUNDRED FIFTY NINE PESOS ONLY (P 146,459.00)** for the delivery of goods under Negotiated Canvass No. - PHO - 2020 - 275;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings
