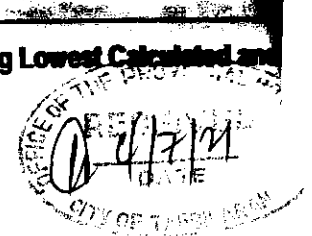


**BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval**



**RESOLUTION NO. 21-073

**WHEREAS, the PROVINCIAL MOTOR POOL OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0854; re; Procurement of Universal Machine Oil and High Alloy Electrode for the Automotive Maintenance Division, by the Provincial Motor Pool Office, New Capitol Compound, Tagbilaran City. with an ABC of P 125,788.48;**

**WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that CRO-MAGNON CORPORATION offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;**

**WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of CRO-MAGNON CORPORATION including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid CRO-MAGNON CORPORATION, has been found to be ELIGIBLE and its bid, RESPONSIVE;**
