WHEREAS, the PROVINCIAL ENGINEER'S OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0192, re: Procurement of Labor and Materials for the Repair of Isuzu Crosswind, SJC-472, Provincial Engineer's Office, New Capitol Compound, Tagbilaran City, with an ABC of P 158,000.00;




