WHEREAS, the PROVINCIAL ENGINEER'S OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0192; re; Procurement of Labor and Materials for the Repair of Isuzu Crosswind, SJC-472, Provincial Engineer's Office, New Capitol Compound, Tagbilaran City, with an ABC of P 158,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that TAGBILARAN CITY TYRE SALES & SERVICE CENTER offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
