Assigned by the Office of the Provincial Motor Pool, Bohol Provincial Capitol Compound, Cogon District, Tagbilaran City. with an ABC of P 147,544.00;


WHEREAS, the above Procurement Request was presented to the BIDS AND AWARDS COMMITTEE for deliberation and proper action;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:


