



BAC Resolution Declaring LCRQ and Recommending Award

RESOLUTION NO. 7-0770 Series of 2021

WHEREAS, the GOVERNOR'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2021-C-036 re: PROVISION OF MEALS AND SNACKS FOR THE INTER-AGENCY INTELLIGENCEFUSION. COORDINATION MEETINGS, STRATEGIC AND OPERATIONAL PLANNING WORKSHOP, PERFORMANCE ASSESSMENT, CAPACITY DEVELOPMENT, TECHNICAL TRAININGS AND SEMINARS AND OTHER RELATED COLLABORATIVE ACTIVITES FOR LAW ENFORCEMENT AGENCIES with an ABC of P 750, 375.00;
