



**BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval**

WHEREAS, the **OFFICE OF THE PROVINCIAL AGRICULTURIST** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. **2020-0917** re; **Procurement for the Enhancement of Billar Multi-Species Freshwater Fish Hatchery, Office of the Provincial Agriculturist/Fisheries Division, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City,** with an ABC of **P 99,231.56;**




