WHEREAS the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 20-1067 series of 2020 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode, and was duly approved by the Honorable Governor, authorizing the use of the said Method of Procurement by the OFFICE OF THE PROVINCIAL AGRICULTURIST in undertaking Procurement Request under PR No. 20-2019 re: Procurement of Brand New Vehicle (10-Footer Flextruck Van Type) in Support to Organic Agriculture Program of the Office of the Provincial Agriculturist, New Capital Site, Tagbilaran City, with an ABC of P 1,400,000.00;



WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, TOYOTA TAGBILARAN CITY has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:


- a). To declare TOYOTA TAGBILARAN CITY as the suppliers with the Lowest Calculated and Responsive Price Quotation for the Delivery of Goods/Services under Negotiated Canvass No. 2020-0019 (2nd Failure);
- b). To recommend award to TOYOTA TAGBILARAN CITY in the amount of P 1,387,200.00 of delivery of goods/services under Negotiated Canvass No. 2020-0019 (2nd Failure);
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
