

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value Responsive Quotation and Recommending Approva

> RESOLUTION NO. 21-0240 Series of 2021

WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0447; re; Procurement of Steel Roll Up Door, Door Panel, Door Jamb & Electrical Fixtures, by the Office of the Provincial Agriculturist, New Capitol Compound, Tagbilaran City, with an ABC of P 450,000.00;
