THIS AGREEMENT, made this ¹⁰⁰⁷⁻⁵ 5th day of May, 2021 between Provincial Engineer's Office of Provincial Government of Bohol (hereinafter called the "Entity") and BOHOL ARCH CONSTRUCTION AND DEVELOPMENT (BARCODE) CORPORATION of G/F 0548 Zosima C. Revita Real Estate Lessor, J.A Clarin St., Dampas District, Tagbilaran City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **CONSTRUCTION OF LANDMARK AT PUNTA CRUZ WATCH TOWER COMPOUND AT PUNTA CRUZ, MARIBOJOC, BOHOL** (hereinafter called "the Works") and the Entity has accepted the Bid for P 1,960,316.00 in **One Million Nine Hundred Sixty Thousand Three Hundred Sixteen Pesos Only** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.
