WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0217, series of 2021 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL ENGINEER'S OFFICE in undertaking Procurement Request under PR No. 2021-0121 re: Procurement of Various Vehicle Spare Parts for Replacement of Defective Parts, Etc. For Mitsubishi Strada with Plate No. SKN-820, Provincial Engineer's Office, New Capitol Compound, Tagbilaran City, with an ABC of ₱ 111,120.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that TAGBILARAN CITY TYRE SALES & SERVICE CENTER offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;




