WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2021-0104 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL GOVERNMENT OF BOHOL in undertaking Procurement Request under PR No. 2021-C-011 re: BULK PROCUREMENT OF CATERING SERVICES FOR THE DIFFERENT ACTIVITIES AND EVENTS OF THE PROVINCIAL GOVERNMENT OF BOHOL FOR THE 1st QUARTER OF CY 2021 – D. PACKED MEAL with an ABC of P 2, 290, 367.50;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that ALTA CEBU VILLAGE GARDEN RESORT, INC. for item nos. 5, 7, 10, 11 & 12; CASA REY FRANCIS PENSION HOUSE AND RESTAURANT for item nos. 8 & 9; REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC. for item no. 2, and PANDA TEA GARDEN SUITES for item nos. 1, 3, 4 & 6 as reflected in the Abstract of Bid Proposals;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, ALTA CEBU VILLAGE GARDEN RESORT, INC., CASA REY FRANCIS PENSION HOUSE AND RESTAURANT, REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC., and PANDA TEA GARDEN SUITES have been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:

- a). To declare ALTA CEBU VILLAGE GARDEN RESORT, INC. for item nos. 5, 7, 10, 11 & 12, CASA REY FRANCIS PENSION HOUSE AND RESTAURANT for item nos. 8 & 9, REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC. for item no. 2 & PANDA TEA GARDEN SUITES for item nos. 1, 3, 4 & 6 as the suppliers with the Lowest and Responsive Price Proposal per Item for the Delivery of Catering Services under Negotiated Canvass No. 2021-030 (2nd Failure);
- b) To recommend award ALTA CEBU VILLAGE GARDEN RESORT, INC. in the total amount of P875,640.00, CASA REY FRANCIS PENSION HOUSE AND RESTAURANT in the total amount of P491,290.00, REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC. in the total amount of P494,000.00 and PANDA TEA GARDEN SUITES in the total amount of P387,764.00 for the delivery of Catering Services under Negotiated Canvass No. 2021-030 (2nd Failure);
