BAC Resolution Recommending the Use of Negotiated Procurement through Emergency Cases, Declaring Single Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY (BOHOL PROVINCIAL ISOLATION CENTER) of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021 – 079 re: Procurement of various Medical Supplies with an ABC of P 800,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that DEXTEL TRADING offered the Single price quotation as reflected in the Abstract of Bid Quotations,

- b.) To recommend award to DEXTEL TRADING for the delivery of goods under Negotiated Canvass No. 2021 – 052 (Emergency Cases) in the amount of P 653,598.00; except for items no. 54, 57, 58, & 59 having no quotations from the supplier is recommended for re-canvass;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
