


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- b. To recommend award B & J COMPUTER SALES AND ELECTRONIC SERVICES INC. in the amount of FOUR HUNDRED NINETY SEVEN THOUSAND EIGHTY PESOS ONLY (P 497,080.00); for the Delivery of Goods under Negotiated Canvass No. - PHO - 2020 - 121 (2nd failure of bidding);
- c. To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.


