WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. _____ series of 2018 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY** in undertaking Procurement Request under **PR No. – PHO – 2020 – 420** re: **PROCUREMENT OF HYDROXYETHYL STARCH 500ML** with an ABC of **P 38,000.00**;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **SAVELINK PHARMA AND TRADING CO.**, offered the lowest price among the suppliers as reflected in the Abstract of Bid Proposals;


