

BAC Resolution Recommending the Use of Negotiated Procurement through Emergency Cases Declared Responsive Quotation and Recommend on Approximately 1997

RESOLUTION NO. Series of 2021

WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY BO-DEPROVINCIAL ISOLATION CENTER) of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021 – 083 re: Procurement of various Medical Supplies & Equipments with an ABC of P 300,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>DEXTEL TRADING</u> offered the Single price quotation as reflected in the Abstract of Bid Quotations,

- b.) To recommend award to <u>DEXTEL TRADING</u> for the delivery of goods under Negotiated Canvass No. <u>2021 DCL</u> (<u>Emergency Cases</u>) in the amount of <u>P 298,744.00</u>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
