BAC Resolution Recommending the Use of Negotiated Procurement through Emergency Cases, Declaring Single Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY (BOHOL PROVINCIAL ISOLATION CENTER) of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021 - 083 re: Procurement of various Medical Supplies & Equipments with an ABC of P 300,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that DEXTEL TRADING offered the Single price quotation as reflected in the Abstract of Bid Quotations,
