

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL HUMAN RESOURCE MANAGEMENT & DEVELOPMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0809, re; Procurement of Computer Inks and Office Supplies for the Office Operation 4th Quarter 2020, by the Provincial Human Resource Management Office, New Capitol Compound, Tagbilaran City, with an ABC of P 413,937.50.

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PARK AVENUE GENERAL MERCHANDISE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

- b.) To recommend award to PARK AVENUE GENERAL MERCHANDISE for the delivery of goods/services under Negotiated Canvass No. 2020-0625 in the amount of P 412,767.00;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
