WHEREAS, the TEODORO B. GALAGAR DISTRICT HOSPITAL, JAGNA, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2020 - 318 re: PROCUREMENT OF OFFICE FURNITURES FOR DIFFERENT OFFICE AND STATIONS with an ABC of P 580,000.00;



WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of SKETCHES & PLOTS FURNITURE & FIXTURES ENTERPRISE including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid SKETCHES & PLOTS FURNITURE & FIXTURES ENTERPRISE has been found to be ELIGIBLE and its bid, RESPONSIVE;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- b.) To recommend award to SKETCHES & PLOTS FURNITURE & FIXTURES ENTERPRISE in the amount of FIVE HUNDRED SEVENTY NINE THOUSAND PESOS ONLY (P 579,000.00) for the delivery of goods under Negotiated Canvass No. - PHO - 2020 - 245;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
