

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the FRANCISCO DAGOHOY MUNICIPAL HOSPITAL, INABANGA, BOHOL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2021 - 062 re: PROCUREMENT OF ISOLATION GOWN, FACE MASK, OR CAP/HEAD GEAR, DISPOSABLE SHOE AND GLOVES EXAMINING with an ABC of P 100,100.00.
