WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0237; re; Procurement of Tarpaulin & Wooden Plaque for Agricultural Fishery Programs, Projects and other Activities or Different Commodities in Support to Crop Production in the Province, Office of the Provincial Agriculturist-RASS, Prov.Coop Devt. Council, Corn Rice, Admin & Fisheries Division, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, Bohol with an ABC of P 94,560.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that CENTROID PRINTSHOP offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:




