WHEREAS, the PROVINCIAL ENGINEER'S OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0638; re; Procurement of Labor, Materials and Equipment for the Improvement of the Working Space for the PEO Project Management Division (PMD) at the Provincial Engineer's Office, New Capitol Site, Tagbilaran City, Bohol with an ABC of P 206,484.92;


