WHEREAS, the PROVINCIAL ENGINEER'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0567 re; Procurement of Various Hardware, & Construction Materials for the Repair of Pandol Bridge at Pandol - Fatima Road, Corella, by the Provincial Engineer's Office, New Capitol Compound, Tagbilaran City. with an ABC of P 388,038.31;
