WHEREAS, the PROVINCIAL ENGINEER'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0560 re; Procurement of Hardware & Construction Supplies for use in the Repair of Sagasa Bridge at Poblacion(Catigbian)-Ambuan-Sagasa(Balilihan) Road. Provincial Engineer's Office, New Bohol Provincial Capitol Compound, Cogon District, Tagbilaran City. with an ABC of P 223,260.31;


