WHEREAS, the PROVINCIAL GENERAL SERVICES OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No 2021-0020 re; Procurement for the Renovation of Old LGA Office at the Governor's Mansion, by the Provincial General Services Office, New Capitol Compound, Tagbilaran City, with an ABC of **P 303,893.95**;
