BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the BOHOL TOURISM OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0238; re; Procurement of Vehicle Rental for Inland Transportation Services within Bohol during the Tourism Buyers/Media Familiarization Tour and other Related Activities/Bohol Tourism Office(BTO), Bohol Provincial Capitol Building, Cogon District, Tagbilaran City with an ABC of P 270,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BOHOL AIRPORT DRIVERS AND OPERATORS TRANSPORT SERVICE COOPERATIVE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
