BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the BOHOL TOURISM OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0238, re: Procurement of Vehicle Rental for Inland Transportation Services within Bohol during the Tourism Buyers/Media Familiarization Tour and other Related Activities, Bohol Tourism Office(BTO), Bohol Provincial Capitol Building, Cogon District, Tagbilaran City with an ABC of P 270,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BOHOL AIRPORT DRIVERS AND OPERATORS TRANSPORT SERVICE COOPERATIVE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of BOHOL AIRPORT DRIVERS AND OPERATORS TRANSPORT SERVICE COOPERATIVE including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation BOHOL AIRPORT DRIVERS AND OPERATORS TRANSPORT SERVICE COOPERATIVE has been found to be ELIGIBLE and its quotation RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare BOHOL AIRPORT DRIVERS AND OPERATORS TRANSPORT SERVICE COOPERATIVE as the bidder with the LOWEST CALCULATED AND RESPONSIVE QUOTATION for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. 2021-0128;
- b.) To recommend award to BOHOL AIRPORT DRIVERS AND OPERATORS TRANSPORT SERVICE COOPERATIVE for the delivery of goods/services under Negotiated Canvass No. 2021-0128 in the amount of P 265,400.00;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
