



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the CANDIJAY COMMUNITY HOSPITAL, CANDIJAY, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2021 - 070 re: PROCUREMENT OF VARIOUS OFFICE SUPPLIES with an ABC of P 92,767.25;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that SANDUGO PRESS MARKETING AND SUPPLIES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

- b.) To recommend award to SANDUGO PRESS MARKETING AND SUPPLIES, in the amount of **NINETY TWO THOUSAND FOUR HUNDRED FORTY SIX PESOS ONLY (P 92,446.00)** for the delivery of goods under Negotiated Canvass No. - PHO - 2021 - 043;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings
