



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **CLARIN COMMUNITY HOSPITAL, CLARIN, BOHOL**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2021 - 142 re: **PROCUREMENT OF VARIOUS SPARE PARTS ABC** of **P 109,210.00**;



WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **200M AUTO REPAIR SHOP AND PARTS** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **200M AUTO REPAIR SHOP AND PARTS** has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


- a.) To declare **200M AUTO REPAIR SHOP AND PARTS** as the bidder with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** in the amount **P 109,108.00** for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. - PHO - 2021 - 104;
- b.) To recommend award to **200M AUTO REPAIR SHOP AND PARTS** in the amount of **ONE HUNDRED NINE THOUSAND ONE HUNDRED EIGHT PESOS ONLY (P 109,108.00)** for the delivery of goods under Negotiated Canvass No. - PHO - 2021 - 104;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings




