

CONTRACT AGREEMENT No: 2021-231

THIS AGREEMENT, made this JUL 0 2 2021 day of _________, 2021 between Provincial General Services Office of Provincial Government of Bohol (hereinafter called the "Entity") and C. JANSEN CONSTRUCTION AND GENERAL MERCHANDISE of Poblacion, Danao, Bohol (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute PROCUREMENT FOR THE RENOVATION OF OLD LGA OFFICE AT THE GOVERNOR'S MANSION (hereinafter called "the Works") and the Entity has accepted the quotation for P 303,417.30 in Three Hundred Three Thousand Four Hundred Seventeen Pesos and Thirty Centavos Only by the Contractor for the execution and completion of such Works and the remedying of any defects therein.
