Assigned by the Office of the Governor, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City. with an ABC of P 82,000.00;

- b.) To recommend award to 3 MSG ENTERPRISES for the delivery of goods/services under Negotiated Canvass No. 2021-0104 in the amount of P 81,997.00;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.






