WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. AL-361-21 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL ENGINEER'S OFFICE, in undertaking Procurement Request under PR No. 2021-0303 re: Procurement of Engine Oil, ATF, BF, Gear Oil, Coolant, Lubricants, Etc. for Mitsubishi Strada SKN - 810, SKN - 820, SKN - 840, SKP - 359, Isuzu Crosswind, SJC - 472, Nissan Pathfinder, 7AA-641, Motorcycles, Grasscutter & Chainsaw, by the Provincial Engineer's Office, New Capitol Compound, Tagbilaran City, with an ABC of ₱ 188,150.00;



- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.


