WHEREAS, the **BIDS AND AWARDS COMMITTEE** passed BAC Resolution No. 2021-072 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **CONG. SIMEON G. TORIBIO MEMORIAL HOSPITAL, CARMEN, BOHOL** in undertaking Procurement Request under **PR No. - PHO - 2021 - 053** re: **PROCUREMENT OF DESKTOP COMPUTER AND AIR-CONDITIONING UNIT** with an ABC of **P 234,000.00**;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:



- c. To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
