



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE PROVINCIAL VETERINARIAN of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0328 re; Procurement of Various Veterinary Supplies for use at Office of the Provincial Veterinarian, New Capitol Compound, Tagbilaran City. with an ABC of P 362,350.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that LA CONSOLACION VETERINARY AND FARM SUPPLY offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of LA CONSOLACION VETERINARY AND FARM SUPPLY including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid LA CONSOLACION VETERINARY AND FARM SUPPLY has been found to be ELIGIBLE and its bid, RESPONSIVE;

- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.




